

# COMPLAINTS HANDLING PROCEDURE

Ultima Markets Cyprus Ltd (www.ultimamarkets.eu) with registration number HE423188 and Head Office Address at Georgiou Griva Digeni 122A, Kallinicos Court, Shop 1 – Upper Level, Neapolis 3101, Limassol, Cyprus, is an investment firm authorized and regulated by the Cyprus Securities and Exchange Commission with CIF license number 426/23.



We, Ultima Markets Cyprus Limited (hereinafter, the "Company"), have adopted this Complaints Procedure in order to ensure a fair and quick process for handling complaints that may arise from our relationship.

Under the complaint handling rules, the Company shall deal with any expression of dissatisfaction regarding any financial services activity provided or withheld by the Company.

The Company considers important and essential to pay the proper attention to each and every complaint made by a client, irrelevant of the subject matter of the complaint.

#### 1. Submitting your Complaint

You may submit your complaint in writing and address it to the **Complaints Management Function** of the Company who is authorised to handle and investigate complaints that may be submitted to them from our Clients.

You are encouraged to use the *Complaints Form* attached herein and submit it in the following way:

By submitting the Complaints Form electronically at the following email address: <a href="mailto:complaints@ultimamarkets.eu">complaints@ultimamarkets.eu</a>, along with a copy of any additional documentation that would be relevant to the complaint.

Clients or potential clients can submit complaints to the Company free of charge.


#### 2. Acknowledging your Complaint

We will acknowledge receipt of your complaint within five (5) business days from the receipt of your complaint and provide you with the <u>unique reference number</u> of your complaint. The unique reference number should be used in all your future contact with the Company, the Financial Ombudsman and/or CySEC regarding the specific complaint.

#### 3. Handling of your Complaint

Once we acknowledge receipt of your complaint, we will review it carefully, investigate the circumstances surrounding your complaint and will try to resolve it without undue delay.

We shall make every effort to investigate your complaint and provide you with the outcome of our investigation within two (2) months from the date you have submitted your complaint to us. During the investigation process will keep you updated on the handling process of your complaint. One of our officers may contact you directly (including communication by email or phone) in order to obtain further clarifications and information relating to your

complaint. We will require your full cooperation in order to expedite the investigation and possible resolution of your complaint.

In the event that your complaint requires further investigation and we cannot resolve it <a href="http://www.financialombudsman.gov.cy/">http://www.financialombudsman.gov.cy/</a> within two (2) months, we will issue a holding response in writing or other durable medium. When a holding response is sent, it will indicate the causes of the delay and when the Company's investigation is likely to be completed. In any event, we shall provide you with the outcome of our investigation no later than three (3) months from the period of submission of the complaint.

#### 4. Final Decision

When we reach an outcome, we will inform you of it together with an explanation of our position and any remedy measures we intend to take (if applicable).

In case our final decision does not fully satisfy your demands, we shall explain to you the Company's position on the complaint and set out your options, to maintain your complaint to an Alternative Dispute Resolution (ADR) Mechanism, the Financial Ombudsman, CySEC or the relevant Courts.

If you are not satisfied with the Company's final decision you may check with the office of the Financial Ombudsman of the Republic of Cyprus in case you are eligible to file a complaint with them and seek mediation for possible compensation. It is important that you contact the Financial Ombudsman of the Republic of Cyprus within four (4) months of receiving a final response from the Company, otherwise the Financial Ombudsman of the Republic of Cyprus may not be able to deal with your complaint.

In the unlikely event that the Company was unable to provide you with a final response within the three (3) month time period specified above, you may again contact the office of the Financial Ombudsman of the Republic of Cyprus no later than four (4) months after the date when we ought to have provided you with our final decision.
